AMHS update: Winter Sports Skills Start-Up: Students who have registered and are eligible received an email today with details regarding expectations and protocols. Today's advisory lessons focused on students' mental health. Specifically, 7th & 8th graders discussed the impact of perspective on situations. Next week, Avon will be bringing in an additional group of high school students on Wednesdays to receive more supports. Every week, Avon looks to bring in more students who need additional help. Next week, Mike Hayes and Dawn Stockwell will be joining the School Committee meeting to talk about sports: Fall 2, skills and drills sessions that will be starting on Monday. The Fall 2 sports are slated to have a vote on 2/8.
