The safety and security of the students is a top priority and Superintendent Godino spoke about the reasons why the administrative offices are not appropriate for classroom spaces. Superintendent Godino also expressed her thoughts about the highly qualified and talented middle school teachers at Avon Middle High School and spoke more about the middle school in general. Member Hagberg discussed her experiences that the Avon Public Schools have been amazing to her children and she believes the move could be positive. However, she wants to see a more positive approach prior to the move and ensure parents become more familiar with the Middle High School. Member Chapman spoke about his concerns regarding the parents and the move. Member Marble expressed her disappointment with some comments made regarding the move and hopes the public will go directly to the school committee and not speak through social media. She expressed her largest concern is the preschool class at the High School and the large Kindergarten class coming in the fall. Member Sheehan feels as though there are many benefits towards the 6<sup>th</sup> move to the Avon Middle High School. All those in favor, Aye Paul, Aye Anne, Nay Maria, Abstain Sharon, Aye Tracy.
